Future Geelong Map

The Committee for Geelong unveiled the interactive Future Geelong Map at their Annual General Meeting on Thursday 26 October 2023.

The map is the final deliverable of the Committee for Geelong's Future Geelong project.

This piece of work was commissioned in 2022 by Committee for Geelong, as a project for its members, engaging the services of Tract Consultants.

Designed as a classic Committee for Geelong think piece, the Future Geelong project imagines Geelong at one million residents and began as a series of workshops, gauging the thinking of members around the region in 30 years' time.

Geelong has no shortage of plans, visions, and strategies.


The big ideas, the city-shaping projects are well known. We have captured this in the Future Geelong Map – a platform that brings all these ideas together. The map paints a complete picture of how we will move around, where we will live, what jobs there will be, and how we will play.

Existing projects are combined with approved concepts and plans, aspirational projects, and case study examples.

The map is the perfect tool to use as a regional discussion piece with Government, private enterprise, and the broader community.

The Future Geelong Map is not a static report; the map will continue to evolve and be updated with new information, new ideas, and new aspirations for Geelong – and we welcome collaboration.





Community Leadership Portfolio

In 2023, twenty-eight emerging leaders from the Geelong region embarked on the eighteenth annual Leaders for Geelong program. The cohort thrived under a blended learning approach which combined workshops, online seminars, interactive offsite days around the region, and a hands-on community project. The blended format offered participants a unique and enriching experience. Online seminars provided flexibility and access to diverse expertise, while interactive offsite days allowed them to explore different locations and gain firsthand insight into the challenges and opportunities facing local communities.

The hands-on community projects enabled participants to apply their newly developed skills to address a real community need. This practical experience not only reinforced the value of leadership but also demonstrated the power of community engagement to drive positive change.

The Leaders for Geelong program provides a rare and valuable opportunity for participants to sharpen their leadership abilities, deepen their regional understanding, build strong connections within the community, and establish networks that will continue to support them in their future leadership roles.

Community Projects

Each year, Leaders for Geelong participants work on a community-based project of regional significance. Each project has a Project Champion, who plays a crucial role as the advocate and representative of the organisation receiving the project. Additionally, the project teams are supported by an Alumni Mentor (Leaders for Geelong program alumnus).

Leaders for Geelong participants undertake the program because they are interested in the community service aspect of leadership. They are keen, devoted and take great pride in these projects. This opportunity provides growth for the participants and also for the community organisations, with some of the most talented, energetic and skilled professionals in Geelong supporting them.

2023 projects

Marketing the Barwon Disability Resource Council

The project was to develop and deliver a Marketing Plan that will identify strategies to build upon the BDRC's existing plan management clientele, to bring in more revenue to the organisation to allow them to continue to deliver free disability advocacy for those who rely on them.

P-TECH Mentoring Program Regeneration

The scope of the project was to review and assess the effectiveness of the current P-TECH model delivered through Newcomb Secondary College and to make best practice recommendations for the successful renewal of the model post COVID, supporting students to develop job ready skills to meet current and future workforce demands.

Encouraging the Return of Volunteers to Barwon Health

The project scope was to offer recommendations on how to encourage the return of volunteers to Barwon Health by examining the healthcare and volunteering landscapes. This exploration helped identify both the challenges and potential opportunities available to Barwon Health in revitalizing its volunteer program.

What Works Best for Clients at Lazarus

Due to the increasing rate of homelessness, this project team was asked to undertake an evidence-based research assignment that would provide a pathway to improve services for Lazarus' participants. The research led to undertaking a series of interviews with participants and volunteers, and complete both an environmental scan and literature review. This process uncovered a number of themes, which have informed recommendations offered to Lazarus.

Stadium Patron Transport Study

The purpose of this project was to complete a study on transport used by patrons travelling to and from the stadium, understand the community's experience of travelling on major event days, and identify what opportunities there are for active transport, public transport and other sustainable options for major event days.

GYE Sponsor Marketing Package

The project aimed to identify an effective sponsorship package that GYE could offer to current and potential sponsors and donors that would enhance the engagement of contributing individuals and organisations and assist GYE with expanded sustainability options. The tiered sponsorship strategy developed by the project team aims to address the evolving needs and aspirations of GYE to secure and expand the Kokoda Program.

Activate Leadership Program

The eight-week Activate Leadership Program was relaunched in August 2023 after a brief COVID enforced break.

The refreshed program, delivered in a blend of live in-person and online sessions, introduces participants to contemporary leadership themes with an emphasis on practical application and personal development. As part of the culmination of the program, participants collaborate in small groups to interview one of our region's community leaders, bringing their learning to life in a short presentation.

INDEPENDENT AUDITOR'S REPORT

TO THE DIRECTORS OF COMMITTEE FOR GEELONG LIMITED

Opinion

We have audited the financial report of Committee for Geelong Limited (the Company), which comprises the statement of financial position as at 30 June 2024, the statement of comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies, and the director's declaration.

In our opinion, the accompanying financial report of Committee for Geelong Limited is in accordance with the Corporations Act 2001 including:

- (a) giving a true and fair view of the Company's financial position as at 30 June 2024 and of its financial performance for the year then ended; and
- (b) complying with Australian Accounting Standards as referred to in Note 1 to the financial statements and the Corporations Regulations 2001.

Basis for Opinion

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Report* section of our report. We are independent of the Company in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110 *Code of Ethics for Professional Accountants* (the Code) that are relevant to our audit of the financial report in Australia. We have also fulfilled our other responsibilities in accordance with the Code.

We confirm that the independence declaration required by the Corporations Act 2001, which has been given to the directors of the Company, would be in the same terms if given to the directors as at the time of this auditor's report.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note 1 to the financial report, which describes the basis of accounting.
